Terms & conditions of registration

Participants to the 2010 Eurosite Annual Conference should read these terms and conditions before registering.

1. REGISTRATION FEE

Conference fee

The conference fee is 'all-inclusive' for hotel accommodation, bed and breakfast from Monday 13 to Thursday 16 September, all lunches and evening meals during the conference and participation in site visits. The fee does not cover personal expenses incurred during the conference. The conference fee is based on a specially negotiated conference rate package, delegates benefiting from significant discounts.

There are a limited number of rooms pre-reserved in the conference venue, the Dunblane Hydro Hotel. We strongly encourage delegates to register as soon as possible to secure a room. Eurosite will liaise with the hotel to confirm room allocations on your behalf.

Daily Delegate Seminar fee

The daily delegate seminar fee is for any individual attending only the day parts of the conference. The fee includes lunch, tea, coffee and participation in day programme events. The fee does not include breakfast, evening meal, hotel accommodation or personal expenses incurred during the conference.
